#### Notes and questions: Discussion

The World Bank is working on a report on education and climate change, forthcoming this summer. It is something to look forward to. They presented preliminary results at the RewirEd.

The FCDO and IRC project on parametric insurance and preparing for and responding to climate events is an exciting new project

IBM and Microsoft are developing tools that utilize Artificial Intelligence I to supplement teaching support or lack of teaching during school closures. Local climate data can be collected and used as early warning systems to prepare for potential school closures and evacuations due to climate events such as flooding, to protect schools, and ensure the continuity of learning.

University College London (UCL) researcher Nicola Walshe of the Center for Climate Change and Sustainability presented a research report on climate change and sustainability education. It highlights the needs for a whole school approach while identifying the scientific, social, ethical and policy complexities of teaching climate. We were reminded by researchers that children and youth in urban areas do not connect to nature; rebuilding that connection is the first step towards understanding climate change.

#### Notes and questions: Ways forward

Potential Connections: Learning through Landscapes- British-based Compass Education FCDO - review their efforts on climate shocks

More focus on informal education- how do we engage young mothers with infants? Cross sectoral engagement critical - let's not bifurcate youth and parents - let's leverage them cohesively. Education in 5 years - what will it look like? Can we have sandbox efforts to leverage tech/AI in a few approach? Next COP: Integrate/penetrate more into the main discussions in Climate Finance

GREEN can weigh in with Normative guidance from GEP: weigh in on the curriculum and green school guidance; teacher capacity development; GREEN and BRACE: discussing better alignment, esp as we are bringing more financing. The mapping is a long game.

How do we start using our connections to *push change*- it needs to happen now! Look at how fundings are evolving

Learning & takeaways:

- Clear momentum of creating support for climate change education
- First at scale example of bringing climate action funding into the education sector (BRACE initiative from GPE, GCF and Save the Children)
- Within education sector, a lot is happening already at grassroots level
- Materials, resources, platforms... for teachers are becoming more and more available, but not in a systematic way and not all teachers have opportunities to connect with it
- The global component of the Greening Education Pavilion was not very visible, which conflicted with the branding of the hub in the run up to COP28
- The Greening Education Partnership working groups seem to lack government representation
- Agenda conflicts between RewirEd and Greening Education Partnerships do not present a strong education sector coalition in the climate action sphere
- RewirEd will become an independent body, with Dubai Cares, Education Cannot Wait and GPE in the board. Not clear for me if the connection with COP will remain.
- USAID & FCDO CAPE funding phase 1 was announced, not yet clear what next phases might look like.
- Challenge now is to unite as education sector, go beyond individual level to build bridges outside of the education sector, for "a-typical funding & partners" for CCE. Otherwise, risk of preaching to the converted and CCE becoming
